### MANDATORY COURSES REQUIRED BY THE OCCUPATIONAL HEALTH & SAFETY ACT:

1.	WHMIS 2009 SIMDUT (French WHMIS)	The WHMIS and SIMDUT Training modules are designed for personnel who work with or in proximity to "Hazardous Materials" as defined under the "Hazardous Products Act". Upon completion, participants will know the purpose of WHMIS, the WHMIS classifications and their symbols, the different WHMIS labels and what information they contain, and what are Material Safety Data Sheets and how to use them.
2.	WHMIS Refresher	A condensed version of our standard WHMIS training course as outlined above. Designed for personnel who have taken WHMIS training within the past 2-3 years.
3.	Lift-Truck (CSA Std. B335-04)	Follows the Canadian Standards Association (CSA) 335-04 requirements for safety theory and is an integral part of full certification for lift truck operators. This course is equivalent to the required 8 hour classroom training specified in the Standard. <i>Participants should have completed this course and passed the course test before taking a "practical" examination.</i>
4.	Ontario MOL Worker Orientation (Bill 160)	This training module is designed for <u>ALL</u> Ontario workers and is mandatory training unless they have had previous training that covers the set curriculum of the MOL. Participants will know their rights, their responsibilities and those of supervisors and management, how to recognize unsafe conditions and what to do about them.
5.	Ontario MOL Supervisor Orientation (Bill 160)	This module is mandatory through Bill 160 for all Ontario supervisors regardless of market sector, unless they have had previous training that covers the set curriculum of the MOL. Upon completion, participants will know their rights, responsibilities, how to recognize unsafe situations and what to do about them. The results should be a reduction in occurrences and accidents through enhanced worker supervision.
6.	Violence & Harassment in the Workplace (Bill 168)	The course is well focused on Ontario's Bill 168 and the requirement for training workers. Upon conclusion, participants will be able to identify potential dangerous situations, warning signs and how to defuse Workplace Violence within the context of the law and their Company procedures. <i>Employers must have a written policy and employees must sign off that they have read it.</i>
7.	Fall Protection	This course is considered essential to all workers working at heights of 3 meters or more in the work place. Participants will be able to identify safe or unsafe conditions and know what measures are required to ensure safety while working at heights. They will understand fall prevention versus fall arrest and how to utilize systems to ensure safety for each.
8.	Accessibility for Ontarians with Disabilities	Learn what you must do to comply with the Ontario Accessible Customer Service Standard. When completed, you will understand the different types of disabilities, how to serve people with disabilities, the role of assistive devices, support persons and service animals. <i>Employers must have a written policy and employees must sign off that they have read it.</i>

RECOMMENDED (NOT MANDATORY) HEALTH & SAFETY COURSES		
9.	Fire Safety	The Fire Safety Training module is designed for all personnel to help them understand the classes and nature of fires and how to extinguish them. It also provides information on different types of fire extinguishers and how to use a fire extinguisher.
10.	Transportation of Dangerous Goods	There are 3 modules, one each for consignor, handler and driver. The modules contain generic information for all 3 then specific aspects for the individuals. Participants can receive their certification by their employer if they satisfy the employer's requirements for both general and specific TDG knowledge.
11.	Back & Lifting Safety	Focuses on a thorough understanding of the structure of the human back and the forces placed upon it during lifting. Participants will learn how to plan for a lift and how to properly execute it to reduce the potential for injury.
<b>Management Suite</b>		
12.	Contains 6 separate training modules plus a "Due Diligence Awareness" module. These modules are prescribed for anyone who manages, directs or supervises another person or persons. In addition, individuals who serve on workplace safety committees will benefit from the courses as they provide essential information on the responsibilities of such committees and the tools they can use to effectively carry out their roles.
